## EBONYI STATE OF NIGERIA LAW NO. 026 OF 2020

#### **SECTION 1**

ALAW TO APPROPRIATE THE SUM OF ONE HUNDRED AND TWENTY-TWO BILLION, EIGHT HUNDRED AND FIFTY-TWO MILLION, FORTY FIVE THOUSAND, TWO HUNDRED AND TWENTY-TWO NAIRA, FORTY-NINE KOBO (\(\frac{1}{2}\)122,852,045,222.49) ONLY TO THE SERVICE OF EBONYI STATE GOVERNMENT OF NIGERIA FOR THE YEAR ENDING 31<sup>ST</sup> DECEMBER, TWO THOUSAND AND TWENTY-ONE AND FOR OTHER MATTERS CONNECTED THERETO.

Long Title

#### **SECTION 2**

**BE IT ENACTED** by the House of Assembly *Enactment* of Ebonyi State of Nigeria as follows:

#### **SECTION 3**

This Law shall be cited as Ebonyi State Short Title Appropriation Law, 2021, Law No. 026 of 2020.

#### SECTION 4

This Law shall be deemed to have come into Coneffect on Friday, the 1st day of January, 2021.

#### **SECTION 5**

The Accountant-General may, when authorized to do so by warrants signed by the Governor of Ebonyi State of Nigeria, pay out of the Consolidated Revenue Fund of Ebonyi State of Nigeria, the sums specified by warrants not exceeding *One Hundred and Twenty-Two Billion, Eight Hundred and Fifty-Two Million, Forty-Five Thousand, Two Hundred and Twenty-Two Naira, Forty-Nine Kobo (\*\*N122,852,045,222.49\*)* only in the fiscal year ending 31<sup>st</sup> December 2021.

#### **SECTION 6**

The sum of Forty -Nine Billion, One Hundred and Forty Million, Eight Hundred and Eighteen Thousand, Eighty-Nine Naira (\*\*149,140,818,089.00) only shall be appropriated to the Heads of Expenditure, inclusive of One Billion Naira (\*\*1,000,000,000.00) only that will be in the Contingency Fund of Ebonyi State

Appropriation of N49,140,818,089.00 of Nigeria for the year ending 31<sup>st</sup> December, 2021 for any unforeseen recurrent expenditure. The components of the Recurrent Expenditures are as indicated in the First Schedule to this Law (8-13).

#### **SECTION 7**

The Accountant-General may, when authorized to do so by warrants signed by the Governor of Ebonyi State Government of Nigeria pay out of the Capital Development Fund of Ebonyi State of Nigeria for the year ending 31<sup>st</sup> December, 2021 a total sum of *Seventy-Three Billion*, *Seven Hundred and Eleven Million*, *Two Hundred and Twenty-Seven Thousand*, *One Hundred and Thirty-Three Naira*, *Forty-Nine Kobo* (\$\frac{1}{2}73,711,227,133.49) only, inclusive of *Two Billion Naira* (\$\frac{1}{2}000,000,000.00) only that will be in the Contingency Fund of Ebonyi State of Nigeria for the year ending 31<sup>st</sup> December, 2021 for any unforeseen Capital Expenditure.

#### **SECTION 8**

The sum of Seventy-Three Billion, Seven Hundred and Eleven Million, Two Hundred and Twenty-Seven Thousand, One Hundred and Thirty-Three Naira, Forty-Nine Kobo (\*\*73,711,227,133.49) only shall be appropriated to the Heads of Expenditure as indicated in the Second Schedule II to this Law (14-18).

#### **SECTION 9**

The Accountant-General may, when authorized to do so by warrants signed by the Governor of Ebonyi State Government of Nigeria pay out of the Contingency Fund of Ebonyi State of Nigeria for the year ending 31<sup>st</sup> December, 2021 a total sum of *One Billion Naira* (№1,000,000,000.00) only for Recurrent Contingencies, and *Two Billion Naira* (№2,000,000,000.00) only for Capital Contingencies.

#### **SECTION 10**

No part of the sums mentioned in Sections 5 and 7 shall be issued out of Consolidated Revenue Fund or Capital Development Fund after 31<sup>st</sup> December, 2021.
