LAW NO. 016 OF 2025

SECTION 1

A LAW TO APPROPRIATE THE SUM OF EIGHT HUNDRED AND EIGHTY-FIVE BILLION, EIGHT HUNDRED AND SEVEN MILLION, ONE HUNDRED AND EIGHTEEN THOUSAND, NINETY-NINE NAIRA, EIGHTEEN KODO (₦885,807,118,099.18) ONLY TO THE SERVICE OF EBONYI STATE GOVERNMENT OF NIGERIA FOR THE YEAR ENDING DECEMBER 31ST, TWO THOUSAND AND TWENTY-SIX AND PROVIDE FOR OTHER MATTERS CONNECTED THERETO.

SECTION 2

BE IT ENACTED by the House of Assembly
of Ebonyi State of Nigeria as follows:

*Enactment***SECTION 3**

This Law shall be cited as *Ebonyi State
Appropriation Law, 2026.*

*Short Title***SECTION 4**

This Law shall be deemed to have come into
effect on *Thursday the 1st day of January,
2026.*

*Commencement***SECTION 5**

The Accountant-General may, when
authorized to do so by Warrants signed by the
Governor of Ebonyi State of Nigeria, payout
of the Consolidation Revenue Fund of Ebonyi
State of Nigeria, the sums specified by
warrants not exceeding, **Eight Hundred and
Eighty-Five Billion, Eight Hundred and
Seven Million, One Hundred and Eighteen
Thousand, Ninety-Nine Naira, Eighteen
Kobo (₦885,807,118,099.18)** only in the
Fiscal year ending 31st December, 2026.

SECTION 6

The sum of **One Hundred and Sixty-Six Billion, Two Hundred and Fifty-Eight Million, Seven Hundred and Ninety-Five Thousand, Five Hundred and Fifteen Naira, Ninety-Six Kobo (₦166,258,795,515.96)** only shall be appropriated to the Heads of Recurrent Expenditure as indicated in the First Schedule (Schedule I) to this Law.

SECTION 7

The Accountant-General may, when authorized to do so by Warrants signed by the Governor of Ebonyi State Government of Nigeria payout of the Capital Development Fund of Ebonyi State of Nigeria for the year ending 31st December, 2026 the total sum of **Seven Hundred and Nineteen Billion, Five Hundred and Forty-Eight Million, Three Hundred and Twenty-Two Thousand, Five Hundred and Eighty-Three Naira, Twenty-Two Kobo (₦719,548,322,583.22)** only.

SECTION 8

The sum of Seven Hundred and Nineteen Billion, Five Hundred and Forty-Eight Million, Three Hundred and Twenty-Two Thousand, Five Hundred and Eighty-Three Naira, Twenty-Two Kobo (₦719,548,322,583.22) only shall be appropriated to Capital Expenditure as indicated in the Second Schedule (Schedule II) to this Law.

SECTION 9

No part of the sum mentioned in Sections 6 and 7 shall be issued out of Consolidated Revenue Fund or Capital Development Fund after 31st December, 2026.

The Purpose of this Law is to authorize withdrawals from the Consolidated Revenue Fund of the State for the year ending December 31st, 2026 and provide for other Connected Matters.


